



Team Contract 2019-2020

2019-2020 Account

*The contract is in effect for the fall session starting Tuesday September 3, 2019 - May 31, 2020. It must be read and fully signed and initialed for each account before enrollment of any student into the JDS dance program. Please read and initial each item. *Please go over this with your dancer.*

- We accept checks, cash, cards & auto-pay. Tuition is due the first of every month & before the eighth. Payments returned for Non-sufficient Funds will result in a \$25 charge.
- A \$25 late fee will be charged on the 8th for tuition & the 15th for other fees.
- Dancers not current on tuition and other fees will not be allowed to participate in class or solo until paid.
- When paying with cash, please get a receipt.
- The studio must be notified by the parent/guardian by Facebook of any student absences.
- Dancers need to attend summer classes.
- Dancers are required to attend the JDS Camp. (unless approved by Jessie or Celeste).
- Team Fee (\$40.00 due with July tuition) is non refundable.
- Team Payments (Sept.-Feb. paid with tuition) are non refundable also.
- Team Jackets (\$65.00) are required for all team members.
- Any dancer that quits from January on will still be held accountable for the rest of the seasons remaining balance.
- I understand the competition dates and rehearsals are mandatory and will set aside these dates on my schedule.
- It is parent's responsibility to keep up to date of student schedule, events and notices through reading the weekly update via Facebook & email, the monthly newsletter that is emailed, posted in the parent portal and in the studio.
- 3 Tardies= 1 Absence, 3 No Dress/Prepared= 1 Absence. Each No Dress after that a will incur a \$5 charge.
- No more than 3 unexcused absences are allowed or dancer will be removed from the team. Excused absences are: Weddings, Funerals, Doctors note stating to stay home (no more than 3), School Performance/Required activities.
- Teacher's have the right to remove any dancer from their routine at any time due to inconsistent attendance, poor behavior or unpreparedness due to lack of rehearsal. They may choose an alternate for replacement or not.
- All dancers are expected to work hard and give their all in every class.
- Dancers and Parents must respect our art, instructors, staff and fellow dancers.

Dress Code

Initial that you have read this _____

Ballet- black leotard (no shorts), pink tights, pink canvas or leather ballet shoes are required (leather for younger). Hair is to be in a bun. (attire and shoes can be ordered through the studio for a lower price than the dance stores)

Jazz/Technique/Acro- All black tight DANCE clothes, nude foot undeez, neoprene's, turners or bare feet. (any dance attire and shoes can be ordered through the studio).

Hip Hop- Tennis shoes and any workout clothes, tight or baggy (jeans not allowed). Hip hop shoes will be ordered.

Hair- bun for ballet, must be pulled away from the face for all other classes.

Competition

Initial that you have read this _____

- Dancers are required to attend classes the week of competition to avoid being spaced out.
- Dancers are required to attend all competitions. (Unless approved by Jessie or Celeste).
- Dancers are required to keep all costumes in mint condition, have spare tights and correct shoes.
- Dancers are required to follow the set hair do, make up colors and style.
- Dancers are required to be ready at their call time.
- Dancers are required to have good sportsmanship and represent JDS with the utmost pride and respect.
- Dancers are required to wear their JDS studio jacket to and from comp and during awards.
